Fierce® EZ is a new liquid pre-emergent residual herbicide that offers extended activity on emerging spring broadleaf and grassy weeds for soybeans and wheat.

Performance tips

1. **Emerged weeds** – use with a burndown herbicide partner like glyphosate and BlackHawk
2. **Flushing weeds** – residual activity for newly emerging weeds
3. **Flexible application** – Fierce EZ alone can be applied pre-plant or up to 3 days post plant
4. Refer to label for rates and use patterns
5. **DO NOT** incorporate after application or prior to planting
6. Leave a small checkstrip in the field to show performance

PRE-EMERGENT RESIDUAL HERBICIDE

ACTIVE INGREDIENTS

- > Group 14 (flumioxazin)
- > Group 15 (pyroxasulfone)

TREATMENT AREA

- > One case treats 80 acres at 180 mL/ac.

APPLICATION TIMING

- > Pre-emergent for soybeans
- > Should be applied a minimum of 7 days prior to planting spring wheat, winter wheat and field corn (no-till only)
- > Apply up to 3 days after planting soybeans

TANK-MIX ORDER

- > Fierce EZ
- > BlackHawk® (if used)
- > Glyphosate

NOTES

- > Planting after herbicide application requires the use of minimum disturbance planting systems
- > Fierce EZ requires moisture to activate in the soil and provides up to 8 weeks residual control
