**6. Accidental Release Measures**

## 11. Toxicological Information

**Likely routes of exposure:** Inhalation, ingestion, skin and eye contact.

**Eye contact:** Causes severe eye irritation / corrosion. Causes redness and tearing.

**Skin contact:** May be harmful if absorbed through skin. Causes slight skin irritation.

**Ingestion:** May cause headache, dizziness, nausea, vomiting, gastrointestinal irritation, weakness and central nervous system depression.

**Carcinogenicity** ..... The International Agency for Research on Cancer (IARC) lists exposure to 2,4-D as possibly carcinogenic to humans (Group 2B), based on inadequate evidence in humans and limited evidence in animals. 2,4-D was not carcinogenic to rats or mice in lifetime feeding studies. Mecoprop-P shows no evidence of carcinogenicity. Dicamba is not considered to be carcinogenic.

**Reproductive toxicity** ..... 2,4-D, mecoprop-P and dicamba are not considered as reproductive toxins.
