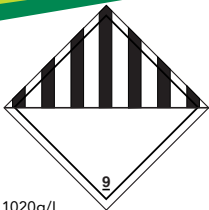

HANDLING PRECAUTIONS

STORAGE: Store in original container tightly closed and in a dry, cool, area away from foodstuffs. Stores containing 1000 litres require secondary containment and signage and more than 1000 litres require emergency response plans.

PERSONAL PROTECTION: Avoid skin and eye contact and inhalation of spray mist. When using wear eye protective clothing such as goggles or face shield, impervious gloves, overalls and boots. Remove protective clothing and wash hands and face thoroughly before meals and after work.

EQUIPMENT: Apply using well maintained and accurately calibrated equipment.

DISPOSAL: Triple rinse empty container and add rinsate to the spray tank. Recycle empty container. Otherwise crush and bury in a suitable landfill. Dispose of product only by using according to the label or at an approved landfill.

FIRST AID

DIRECTIONS FOR USE WITH RETAIN

Read and follow all directions and precautions on the ReTain label.

Use 50ml Freeway per 100 litres on Gala, Royal Gala, Jazz, Envy and related varieties including all crosses and sports. Use 50-100ml Freeway per 100 litres water on other apple varieties. Use the lower rate in hot, dry growing seasons where the surfactant and other products such as calcium may persist longer on the fruit. On new apple varieties only a small area should be sprayed over a number of seasons to determine the suitability of ReTain and surfactant on that variety.

Reduced surfactant rate will marginally reduce the performance of ReTain. Do not use more than 100ml/100 litres water.

NOTE: Fruit Spotting Risk: Due to factors such as but not limited to calcium use, sunburn, variety and climatic conditions (eg high humidity and low rainfall) the use of Freeway may in some circumstances increase the risk of fruit spotting. Higher surfactant rates and increasing use of calcium, especially during periods on warm dry weather when calcium sprays are not washed off, can increase this risk. Growers must determine their own risk of fruit spotting and accept responsibility for any spotting as a result of the decision to spray.

To minimise foaming, add Freeway to the tank last when it is nearly full of water. Do not apply ReTain/Freeway mixture in late afternoon if the fruit is still warm. Do not apply with any other product. Allow 24 hours between the application of ReTain/Freeway and any other agricultural product.
