STORAGE

- Store in original container tightly closed in a locked, dry, cool area away from foodstuffs. Store in accordance with NZS8409 Management of Agrichemicals.
- Stores containing more than 1000kg require emergency response plans, secondary containment and signage.

PERSONAL PROTECTION

- Use only outdoors or in a well-ventilated area.

DIRECTIONS FOR USE

Do not administer directly to animals and do not graze animals during application.

FOR PASTURE / FODDER CROPS

Use 0.5kg/ha every year, or 1kg/ha every 2 years, either direct or with granular fertiliser. This provides 12 months selenium supplementation for all grazing livestock (*except dairy animals) and 24 months supplementation when applied at 1kg/ha.

*Dairy: for intensive dairy pasture situations apply at 1kg/ha every year.

Apply during active pasture growth (spring, autumn).

Uniform coverage is advisable.

TO SUPPLEMENT SELENIUM IN WHEAT GRAINS

For both autumn and spring sown crops broadcast 500g – 1kg/ha Selcote Ultra at stem elongation (GS31).

Selcote Ultra can be mixed and applied with urea.

Alternatively for spring sown wheat apply 1kg/ha Selcote Ultra with the base fertiliser at sowing.
