4. First-aid measures

11. Toxicological Information

Ingestion	Ingestion of the concentrate in relatively large amounts can result in headache, nausea, lethargy, motor weakness and incoordination. If aspirated into the lung, e.g. from vomiting, the presence of surfactants may result in chemical pneumonitis or other lung damage.
Inhalation	The components of the product are of low volatility and no adverse effects are expected from handling the concentrate. However, care should be taken to avoid the inhalation of excessive amounts of spray mist during field spraying, respiratory irritation may occur.
Skin	Prolonged contact with the concentrate may cause irritation. Prolonged contact with the concentrate can cause defatting of the skin and may result in dermatitis. Prolonged contact with the concentrate may result in absorption of butyl diglycol in harmful amounts.
