



FRAGMA[®] MAX

Authorisation Update

The product authorisation for FRAGMA MAX has been updated and now includes an extended range of permitted joint applications with other ALS herbicides, including formulations with grass weed activity.

- ✓ The MAPP number has been updated from MAPP 21169 to MAPP 21701.
- ✓ Existing stocks of FRAGMA MAX bearing the number MAPP 21169 may be applied in line with the revised joint application options provided a copy of the updated label text is made available to be read by operators prior to mixing/spraying and the conditions of use on the new label are met in full.

FRAGMA MAX (MAPP 21169) can be sold until 30/11/2026, with a further 12 month use-up period on farm, meaning any carryover stock remaining in farm stores may be used before 30/11/2027.

A *JOINT APPLICATION* is the use of a product in tank mixture or sequence with another product and should only be made within the label recommendations of every product in the application.

FRAGMA MAX (MAPP 21703) may be applied in joint application to the same cereal crop with one of the following ALS products:
