USE SUMMARY

RATES AND TIMING

Apply this product at rates of 1 to 6 quarts per acre for the control of broadleaf weeds and woody plants. Apply in enough water to provide uniform and complete coverage. For best results, make applications when woody plants and weeds are actively growing. Use higher rates when brush averages 15 feet or more in height or when brush covers more than 60 percent of the area to be treated.

APPLICATION RESTRICTIONS

GRAZING OR HARVESTING GREEN FORAGE

Beef cattle: No grazing restrictions if applications are 2 quarts per acre or less or if less than 25 percent of a grazed area is treated.

See product label for additional grazing restrictions and for intervals for dairy animals. Consult product label for haying intervals.

SLAUGHTER RESTRICTIONS

Withdraw livestock from grazing treated grass or consumption of treated hay at least three days before slaughter.
