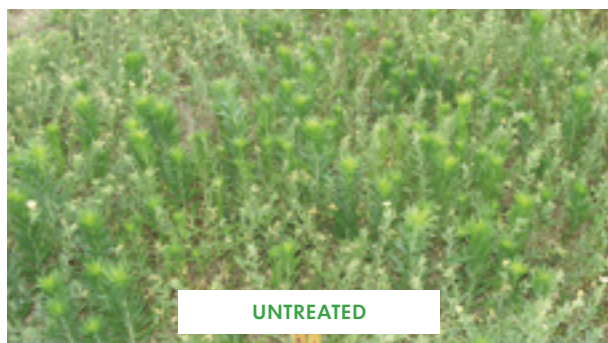

2. Marestalk begins germinating in the fall and can continue into the spring
3. Best control requires treating marestalk in the rosette stage in the fall or early spring AND following up with an effective residual program
