

# FAIRY RING PREVENTION ASSURANCE PROGRAM

Keep your course pristine with Nufarm's Fairy Ring Assurance Program for greens & tees. Fairy ring patches, fruiting bodies and turf scarring can disrupt surface consistency and smoothness. As curative fungicides are often too little too late, this tricky disease is best managed preventatively. Fairy ring symptoms can be caused by over sixty different fungi. These fungi feed on dead organic matter in the thatch and soil, not on grass roots. As they thrive, they make the root zone hydrophobic, preventing water from penetrating. This leads to drought conditions, ultimately causing the grass to die.

## PROGRAM GUIDELINES

- **Preventative Spring Application Timing:**  
For all states except Florida, Hawaii and Texas, schedule the first spring application when the 5-day average soil temperature at a 2-inch depth is between 55-60°F. For Florida, Hawaii, and Texas, use a 5-day average soil temperature of 70°F.
- **Application Method:**  
Apply with 3-5 gallons of water per 1,000 sq. ft. and immediately water-in to the depth of active fairy ring mycelium.
- **Soil Wetting Agent Program:**  
Where soil hydrophobic conditions have developed, tank-mix an appropriate soil wetting agent, follow manufacturer label recommendations.
- You can apply soil surfactants on their own or tank-mix them with Tourney EZ, or strobilurin treatments.
- **Turf Health Maintenance:**  
Maintain adequate soil moisture levels for turf health, follow BMPs for wetting agents, aeration and thatch management.
- **Additional Disease Management:**  
This program also inhibits mini ring on bermudagrass and seashore paspalum, and prevents summer patch, dollar spot and take-all patch on creeping bentgrass and Poa.

## GREENS & TEES ASSURANCE PROGRAM

- **Purchase Requirement:**  
Program products must be purchased from an authorized Nufarm distributor.
- **Application Guidelines:**  
Use the prescribed program, application rates and product use directions to effectively control fairy ring.
- **Breakthrough Claims:**  
Report any breakthrough claims to a Nufarm regional sales manager, including spray records with details on soil temperature, carrier volume, and post-application irrigation at the time of treatment. "Breakthrough" is defined as by the appearance of fairy ring symptoms that negatively impacts the playability of the turf. Nufarm's representative to make judgment in its sole discretion whether breakthrough has occurred notwithstanding product applications at prescribed application rates and in accordance with label instructions.
- **Response to Breakthrough:**  
If applicable, Nufarm will determine the program and products to provide for treatment and whether a broadcast or spot treatment is necessary.
- **Assurance Coverage:**  
The assurance program commences from the date of the first preventative application through until the end of August that same year. The assurance program covers up to two curative fungicide applications, limited to the acres of turf originally treated where breakthrough has occurred.

## TERMS & CONDITIONS

- **Replacement Product:**  
Nufarm will cover only the cost of the replacement Nufarm fungicide products; no other costs or expenses, including the application costs of the curative treatment(s), will be covered by Nufarm.
- **Claim Qualification:**  
Claims must be filed within thirty (30) days of seeing fairy ring breakthrough to your local Nufarm regional sales manager. Nufarm's decision on whether fairy ring control is acceptable will be final.
- **Required Documentation:**  
Complete spray records, including rates, application dates, watering amounts, and other documentation reasonably requested by Nufarm must be provided. Claims without full documentation will not be processed.
- **Program Modifications:**  
Nufarm reserves the right to modify or discontinue this Assurance Program at any time.
- **Legal Compliance:**  
This program is not available where prohibited by law.
